Good things

Things we need to look at

- Needs ownership of who takes lead responsibility for support
- Court processes not user friendly
- Ending of Mencap service –well liked and nothing to replace it
- Dearth of support services

Changing Places

Changing Places

Consideration of Changing Places by other public bodies

Advocacy

- Changing need for advocacy e.g.
 - Mental Capacity Act
 - Individual budgets
 - People getting older
- Case advocacy – now a contract
- Citizen advocacy – big demand
- Overall advocacy plan for Council
- Need to revise and strategy to reflect these

Court Work

- They want us to help with things like
 - Making the building accessible
 - Protocol for criminal law
 - Making court paperwork accessible
 - Awareness raising of people with learning disabilities with staff
