Tyne and Wear NHS Trust, Newcastle Hospitals NHS Trust –and the Primary Care Trust. The group meets quarterly.

This group gives support and direction to the Supporting the Carers Strategy Group is the Carers Strategy Implementation Group which includes has representation from carers of people with a learning disability.

Whilst this group also has an information sharing role, its main focus is to make the strategy happen. It has a number of working groups supporting the group including A group organising a training course for carers to become more confident to represent themselves and other carers Confidence building , Emergency Support, Support, Carers Information Pack and a group planning an event for this year's Carers' Rights Dayn events planning group
A working group is also being set up to plan and hold a carers conference in or around Carers Week in June 2009.

- carry out carers assessments and
- to do social work interventions

~~The team will also be a specialist Carers resource within Adult Services, providing advice, support and guidance and raising awareness of the needs of carers and the role of the team in Adult Services and, as appropriate some Health and Voluntary sector. It is stressed that the carers these assessments can indicate if caring relationships are at a critical or substantial risk of breaking down and look at whether there is any support available that could help. then these assessments can get people extra support.~~

~~One of the main things the team will be doing is to help carers think about how they come to terms with their caring role – therapeutic support for carers in their own right. In particular its hoped it will help some carers come to terms with accepting help from statutory services . The nature and role of the team is a model that worked well in other areas – I wouldn't say it's the main thing, and it's not particular to carers coming to terms with accepting help, as that's just one example of how it might help. Perhaps instead of that paragraph, talk about how Tthe kind of social work intervention/ support the social workers will carry out will depend on the needs of the individual carer, but may include therapeutic-type social work intervention, supporting carers to work through issues associated with their caring relationship. Alternatively, Or assistance may be more practical, like signposting, advice or information. Working with the caseworker for the cared for person will be an important part of many cases.~~

~~Flexibility will be a key characteristic of the Team's structure and approach – I probably wouldn't include that as it doesn't really relate to anything and I think if you say some of the above about the work of the team that will mean more.~~

~~The team will work in partnership with other social work teams. It's recognised that some carers don't want separate want separate assessments and for these people we need to make sure that their needs are given proper consideration in people with learning disabilities `assessments` assessments.~~

information pack and will include a 'Directory' of some agencies to contact for further specialist information if required. The carers information pack is about trying to give carers some information but not overload people and if they want to find out more they can. Also trying to make this appeal to people who look after someone but may not yet identify themselves as a 'carer' as the term 'carer' can be a barrier to some people accessing support, as they may not consider themselves as such but have that role.

Carers Assessment Tool

Alex has devised a new Carers assessment Tool for separate assessments of the needs of adults caring for adults in Newcastle. that the team will use In developed this tool, some focus groups were held with carers through Partners in the Newcastle Carers Strategy.

Alex has met with Carers of people with learning disabilities at Welford and Westerhope to discuss the carers assessment process and included a number of an areas including
What discussion around what would a positive carers assessment be like for them – what came out of this included some of the kinds of things they felt they would want to talk about as carers of someone with a learning disability – discussions around the future was a major point to come out of this

I've re-worded the above as it's important to stress that the focus groups were about the whole process, rather than focussing on the actual individual assessment (which should be focussed around the individual carer and take their individual needs into account anyway):

General feedback I've given on the focus groups if you want to include anything on this has been some the feedback included—A
a positive Carers Assessment Process should be about taking into account the carer's individual situation, recognising their expertise, supporting them to talk through issues they want to discuss, open communication and providing relevant information and support.

Hidden costs of Brokerage

Brokerage cannot happen by itself - how to avoid a brokerage industry BUT has appropriate support available;

If a budget being offered will be the default option there must be an implicit assumption of appropriate support available to help a person and their families steer through the self directed support world – what support is being considered and how will this be offered?

Use of individual budgets and existing services – if a person still wants traditional services will this be accepted and, if so, how will these be commissioned?

Will Brokerage costs be part of set up plan?

Suspect that this will be part of package as it is at present where 'providers' have acted as brokers?- question for Colin Williams at the December meeting

How important will provider development is to the transformation agenda in Newcastle and along this, robust quality monitoring? We have particular concerns that a momentum will be created and a lot enthusiasm that could be potentially be dashed if the providers cannot provide what people want

Will there be some transformation monies passed onto third sector to boost essential infrastructure such as the role undertaken by NSNN in Dynamite pilot? I.e. how will the use of transformation monies be linked to achieving on the ground outcomes

Can we know more about the Shop4support website and what is Newcastle's position about taking part in this?

What will be the role of the social worker in relation to families in the transformation agenda?

- How do you maintain the importance of the respite care function in an individual budget world - a key example here being if a person chooses not to have a short break because say they don't want a break – what about the carer's need for respite

- Reduced days for respite care – what does this mean for carers?

- National issue - Respite care funding for carers' breaks will be paid to PCTs ***Ref National Strategy – page 73-74 points 3.11 +*** They are required to work together with Social Services to agree how best this will be used . ***Carers Strategy has identified it needs to be spent***I would next just say something broad about Newcastle Carers Strategic Group and Carers Strategy Implementation Group is aware and seeking further details of this funding – we can't identify it needs to be spent (though we agree, and have, that if there is funding available for carer breaks then we should aim to influence the way this is used) until we have more clarity – which is what you say next - .We need greater clarity nationally about

- How much
- Is it "new" money
- What can it be used for
- What influence can carers have in the spending of this money

It has been suggested that whilst the Carers Strategy Group and Carers Strategy Implementation Group are seeking clarity through their networks it might be a good idea to use the launch of Valuing People Now as an excuse to ask the VPST to pursue this on our behalf.
